In addition, we ask you to follow certain rules of conduct during your stay. In case of not following the rules, you may have to leave our campsite.

As we do not want you to leave our campsite prematurely, please make sure to always observe the special regulations with respect. Please fill in the following information (page 1) and read and follow the rules of conduct (page 2) during your entire stay on our facility. Thank you for your understanding!

## **Please note the following rules during your stay at the campsite:**

The legal acts of the federal government as well as of our federal state also apply to our campsite. Please find all regulations online at [www.bvcd.de](http://www.bvcd.de). For an English version you can have a look at [www.rki.de](http://www.rki.de).

- Mouth and nose protection must be worn in all community facilities, regardless of the time of the day and the number of visitors.
- Please always disinfect your hands before entering and leaving community facilities. Use the donors provided for this.
- Wash your hands regularly for at least 30 seconds. Use soap and hot water if possible.
- Keep a distance of at least 1.5 meters from all people who do not belong to your household and avoid touches such as shaking hands or hugs.
- Keep the cough and sneeze in a tissue (or in your elbow if there is no tissue)
- Please follow the instructions of our employees regarding distance and hygiene rules.
- In cases of gross and / or repeated violations of these rules for a safe coexistence, we reserve the right to issue a ban on the premises to protect employees and other guests. We would like to point out that in this case claims for damages may also arise.
